ARU's Environmental Practitioner Degree Apprenticeship will help develop a competent professional individual, equipped to solve environmental challenges and make a real impact in the workplace. Study for an honour's degree in Environmental Management while you work, with no tuition fees. .

This course will help you make a difference to the environment and sustainability in your organisation. You'll learn the fundamentals of environmental science and gain practical skills in environmental data management.

Typical job roles include Environment impact assessor, Environmental (monitoring) assessor, Environmental advisor, Environmental auditor, Environmental consultant, Environmental coordinator, Environmental engineer, Environmental practitioner, Environmental protection officer, Environmental scientist and Land use planner.

Degree apprenticeships are fully funded by employers and the Government. They are also work-based so employees do not have to pay fees to improve their skills, whilst delivering impact in the workplace as they learn. Entry criteria applies.

Delivery & Assessment

At least 20% of contracted working hours are classed as 'off-the-job'. This time will be dedicated to developing the knowledge, skills and behaviours (KSBs) needed to meet the requirements of the apprenticeship and is not part of your usual work duties. The off-the-job learning for our Environmental Practitioner Degree Apprenticeship is delivered online with one-day workshops on our Peterborough campus every other week.

Assessment is at the end of each module undertaken (on-programme assessments) which will contribute towards the final award of the qualification. End Point Assessment (EPA) is also undertaken to complete the apprenticeship. The EPA for this apprenticeship is independently assessed and takes place when all on-programme assessments have been successfully passed.

The EPA will enable you to demonstrate your competence against all areas of the apprenticeship standard and consists of two elements: a strategic business proposal and a portfolio of evidence.
