ARU's Senior Leader Apprenticeship (SLA) offers an exciting opportunity to develop and hone your leadership skills, make a real impact in the workplace, and support your future career aspirations, all while you work, with the plus of CMI accreditation.

It is ideal if you are new to a leadership / senior management role and applicable to a wide range of settings across public, private or third sectors and all areas of the economy. You will be enrolled onto a Senior Leader Apprenticeship with the option of a qualification in the form of a PG Diploma. This will be charged at a nominal fee of £550.

The CMI is the End Point Assessment organisation. Successful completion of the Senior Leader L7 apprenticeship leads to the award of either Chartered Manager or Chartered Fellow status. This accredited programme enables apprentices to apply to the CMI for ongoing professional membership of this internationally recognised professional body.

Degree apprenticeships are fully funded by employers and the Government. They are also work-based so employees do not have to pay fees to improve their skills, whilst delivering impact in the workplace as they learn. Entry criteria applies.

## **Delivery & Assessment**

At least 20% of contracted working hours are classed as 'off-the-job'. This time will be dedicated to developing the knowledge, skills and behaviours (KSBs) needed to meet the requirements of the apprenticeship and is not part of your usual work duties. Off-the-job learning will be delivered through study blocks at corporate venues in Cambridge and Chelmsford, subject to viability.

Assessment is at the end of each module (on-programme assessments) which contribute to the final award of the qualification. End Point Assessment (EPA) starts once an employer is content that an employee is working at or above the occupational standard. The End Point Assessment Organisation (EPAO) is responsible for confirming gateway eligibility.

The EPA will enable you to demonstrate your competence against all areas of the apprenticeship standard and consists of two elements: a strategic business proposal and a portfolio of evidence.
